After reviewing additional filings from the parties, including a response to the Contestee's motion filed by the Contestant and a reply filed by the Contestee, the Committee on House Administration voted on March 10, 2021, to postpone disposition of the motion to dismiss. On March 31, 2021, Contestant Hart announced she would withdraw her contest. A letter of withdrawal from Contestant Rita Hart, mailed on March 31, 2021, was transmitted to the Committee on House Administration by the Clerk of the House on April 8, 2021. After a review of House and Committee precedent in contested elections cases in which the contestant withdraws, I have determined further House or Committee action is required to dismiss the contest. The contestant's letter of withdrawal was entered into the record of the Committee on House Administration's Markup on April 28, 2021, and the Committee will take no further action on this contest.*
